• Permit: Class N (Digital Nomad) — for remote workers with foreign income. • Typical fees: Application ~USD 200 (non-refundable), Issuance ~USD 1,000/year (confirm on eFNS). • Typical validity: 1–2 years. Processing: expect 4–12 weeks (varies).

# File format & naming — time-savers

• Use PDF for documents; JPG/PNG for photos. Prefer A4-sized PDFs, 300 DPI scans. • Keep file names short, descriptive, lowercase, and hyphenated. Examples: passport-john-doe.pdf, contract-acme-inc.pdf.

#### eFNS submission tips

- Create/verify your eFNS account email before starting the application use the same email across documents.
- Complete fields carefully; double-check names, passport numbers, dates and KRA PINs (if requested).
- Upload one document per field; match the document to the field name in the portal.
- If portal accepts comments/notes, include a 1-paragraph summary of your income source and remote status.
- Save payment receipts and take screenshots of submission and confirmation messages.
- Respond promptly to document requests from Immigration to avoid delays.

#### Fees & typical timelines

• Application/processing fee: ~USD 200 (non-refundable). • Issuance fee: ~USD 1,000 per year (paid on approval). • Typical processing: 4–12 weeks; allow extra time for verifications and peak periods.

#### Common mistakes to avoid

- Incomplete or illegible scans (use 300 DPI minimum).
- Mismatched names or passport numbers across documents.
- Missing proof of consistent foreign income.
- Uploading incorrect file formats or oversized files.
- Waiting until the last minute to renew or submit.
